The Performance Challenge will be a 3-year program for show seasons 2022, 2023, 2024. See Tennessee Paint Horse Club web site for more information of the 3-year program.

Yearling Challenge Guidelines for 2022 Show Season

This class is for the applicants that have applied and purchased their slot(s) for the 2022 show year. Anyone that purchases a slot(s) and does not participant will **NOT** receive a refund.

Price for the yearling challenge is \$200 with **NO REFUNDS**

Deadline for entry is postmarked May 1, 2022 or personally given to Sheila Bennett or Connie Hunter.

First round of go will be held May 7th & 8th at Middle Tennessee State University in Murfreesboro with 4 judges.

Second round of go will be held August 20th at University of Tennessee Martin in Martin, TN with 2 judges.

Third and final go will be held September 24th at Roan State Community College in Harriman, TN with 4 judges

The tie breaker judge will be announced at each show prior to each class.

All 10 judges' scores with be compiled and scored for an overall score combining the results of the performance halter, Yearling longe line and the Yearling in hand trail classes from all 10 judges.

Five percentage payback placings will be given according to the amount of slots sold.

1st 35% 2nd 26% 3rd 20% 4th 10% 5th 9%

Rules:

1. Open to regular registry and solid registry APHA yearlings
2. May 1st nomination deadline of the 2022 show year. Late entries will be taken up to day of the first show with a \$50 added late fee.
3. Limit to 3 slots per person
4. APHA rules for the yearling longe line and yearling in hand trail classes will apply
5. Copy of each entry's papers will need to be provided to be kept on file
6. There is no requirement that all shows must be attended to participate
7. When corresponding APHA class is available, entry to that class is required and the Challenge class will be run concurrently; i.e. in hand trail and longe line.

8. Class points are calculated based on the number of enrolled Challenge yearlings in that class on that day.

Future Challenges:

Year 2023:

A new Yearling Longe Line Challenge for the 2022 foals

A two-year old Longe Line Challenge (2021) will be added for the yearlings that participated in the 2022 yearling challenge and have **NOT** been shown under saddle as well as for any other entries that did not participate in the yearling challenge for a higher fee.

Year 2024:

Will be a new Yearling Challenge for the 2023 foals

A two-year old Longe Challenge (2022) will be added for the yearlings that participated in the 2023 yearling challenge and have **NOT** been shown under saddle as well as for any other entries that did not participate in the yearling challenge for a higher fee.

A 3-year-old (2021) western pleasure class will be added

Every year of the Challenge Series (yearling, 2 year old, 3 year old) requires a \$200 nomination fee. As we add classes to the series, if anyone wants to nominate a 2 or 3 year old horse that did not start the Challenge as a yearling, they may do so at a higher fee to be determined.
